Step 2: Act

Team up with your staff and Facility Peer Representative (FPR) to complete a patient activity to help patients understand their rights and responsibilities.

- Educate patients and staff using the My Kidney Kit pages. Use the <u>My Education Sheet</u> to document patient goals.
- Talk with your Facility Peer Representative (FPR) to discuss ideas on what resources and activities they would like to see at the clinic to educate patients about their rights and responsibilities.
- Invite your FPR to a team huddle to share their thoughts about patients' rights and responsibilities.
- Share the <u>Patients Rights Personal Plan</u> (pages 25-28) from the Kidney School module with patients.
- Create a bulletin board highlighting a different patient right or responsibility each week. For example:
 - Week 1: Right to Information
 - Week 2: Individualized Treatment Plan
 - Week 3: Treatment Options
 - Week 4: Grievance process

Step 3: Share

Share what your clinic has done with the rest of the Network!

- Ask your FPR for their feedback and encourage them to attend the next <u>FPR Connection Call</u> to share with others!
